The Managing Trustee, Azvargal Aaivu Maiyam, Chennai has applied for establishment of a new Medical College at Villupuram District. Necessary inspection was caused through the Director of Medical Education and report obtained. After careful consideration of the proposal, the Government of Tamil Nadu have decided to issue an Essentiality Certificate to the applicant Trust for applying to National Medical Commission for establishment of a new Medical College in the name and style of "J.R. Medical College and Hospital" at Kiledaiyalam Village, Tindivanam Taluk, an annual intake of 150 MBBS seats, subject to the following conditions and also to fulfill the other associated conditions for approval by National Medical Commission is solely vested with the applicant Trust:-

- a) Before admitting the students the Trust should complete all the construction work, if any, under progress and building completion certificate for these buildings should be obtained. The same have to be furnished before the National Medical Commission.
- Building stability certificate of the hospital building should be obtained from the appropriate authority.
- c) The Trust should also produce mandatory certificates (viz., AERB approval, Environmental Impact Assessment Certificate, Pollution Control Board Certificate, PCPNDT Act Certificate and Blood Bank Certificate) before the National Medical Commission's inspection without-fail.

- d) The Trust should abide National Medical Commission's norms updated from time to time without any lapse.
- e) The Trust should ensure that the undertaking given by them to rectify the deficiencies pointed out by the Government / Inspection Officers before the National Medical Commission's inspection.
- f) The Trust should ensure the availability of 100% faculty, infrastructures, equipment as per the National Medical Commission's norms, clinical and non clinical materials before the National Medical Commission's inspection without-fail.
- g) The Trust should obtain the approval of National Medical Commission.

It is certified that:-

- a. The applicant owns and manages a 330 bedded functional Hospital which was established in Villupuram District.
- b. Essentiality Certificate should be valid for three academic years (2022-23, 2023-24 & 2024-2025)
- c. It is desirable to establish a Medical College in the Public interest.
- d. Establishment of a Medical College at "J.R. Medical College and Hospital" at Kiledaiyalam Village, Tindivanam Taluk, Villupuram District, Tamil Nadu – 604 302" by "Azvargal Aaivu Maiyam, Chennai" is feasible.
- e. Adequate clinical material as per the National Medical Commission norms is available.
- f. The Azvargal Aaivu Maiyam, Chennai owns and possesses 105.09 acres of land in (comprising in V.No.133, Kiledaiyalam Village and V.No.121 Avanampattu Village, Tindivanam Taluk, Villupuram District on which non-agricultural use of land is permitted and a Medical College and Hospital can be established on it.
- g. The building plan of the Hospital and Medical College has been approved by the competent authority, namely Assistant Director, DTCP, Villupuram District vide its Proceedings Ref. No.1399/2022/Vi Ma2, dated 24.08.2022 and the Proceeding of President, Kiledaiyalam Village Panchayat vide its Ref.No.35/2022, dated 29.08.2022.
- h. The Hospital and Medical College have been granted Completion Certificate / Building Use Certificate by the competent authority, namely, Assistant Director (i/c), District Town and Country Planning, Villupuram vide its Roc.No.1746/2022/VM2, dated 18.11.2022.

It is further certified that in case the applicant fails to create infrastructure for the Medical College as per National Medical Commission norms and fresh admissions are stopped by the National Medical Commission, the State Government shall take over the responsibility of students already admitted in the College with the permission of the National Medical Commission.
